#### Board Discussion and Action Items (Board Chair) - 6:47pm

- SCHOOL PERFORMANCE + ACADEMICS (Ma'at Lands + Katie Murphy) -6:47pm
  - School Leader Report (presentation)
    - Ma'at shares updates on the Pre-Opening Checklist
      - Primarily in the last phases of polishing items related to governance, the handbooks and partnership agreement
    - Summer school started on June 29th with 36 students enrolled
    - Funding
      - 4 grants in the pipeline
    - Student enrollment at 66 students, 1 everyday this week
      - Budget is set for 55, but still trying to hit the goal of 75 students due to the movement that happens in the first weeks of school
    - Professional development starts July 20th
    - First day of school August 12
    - Ribbon cutting ceremony September 16 or 17
    - Discussion
      - Chuong asks if that is a big swing from the last report
        - Ma'at confirms it is up significantly and they have planned home visits due to unrepsovie nature
      - What's behind the summer school plan?
        - Will get funding for this next year, but cannot this year so only 1 class and the Mayor's office told them they needed to do this to help prepare students especially after the nature of COVID
      - Stephanie asks what is the Lilly Grant the Enhancing Futures grant?
        - Yes from Ma'at
        - Stephanie comments this is a big deal and the tie to Eastern Star will be helpful
      - Stephanie asks about the strings attached to CARES Act
        - Ma'at shares we didn't receive funding in the first round because we were not open as a school, but now qualify and will have to be mindful of the buckets where you can spend the funding
      - Stephanie asks about the Governor's grant
        - Ma'at's impresion is that this is leftover money that is fairly flexible

- Stehpanie asks if the CARES act has to be spent by the end of the year?
  - Ma'at says no, it's up to 2022 in most cases now
- Katie asks about the 21st century grant
  - Ma'at says the Eastern Star is our other main organization partner in this case.
  - Katie says we should be very careful about where the money should be allocated
- Stephanie shares more on the CARES act about educational opportunities and certifications - could we leverage any of these as we design for the 1st year?
- Ma'at shares that Eastern Star is going to offset some technology costs
- Fall action plan (COVID-19, e-learning, virtual learning) (update)
  - Ma'at shares things are unclear right now and keep changing.
     Only mandate from state health department that if you have a case at your school you have to report it within 24 hours.
  - They met with parents a couple of weeks ago and 90% of them reported they want their kids in schools and understand the risks.
  - Plan is to be here 5 days a week on site, low student ratios, cleaning supplies and procedures being put in place.
  - If something happens, we're equipped for remote learning. Created a schedule, working on the logistics plans.
  - There are a few students that will be definitely starting from home.
  - Stephanie asks what responsibility is for our board, and preparing for this ahead of time so we can act fast
    - If student or teacher gets it
    - PPE access and cleaning supplies
